# New IDER Tool - Basics

---

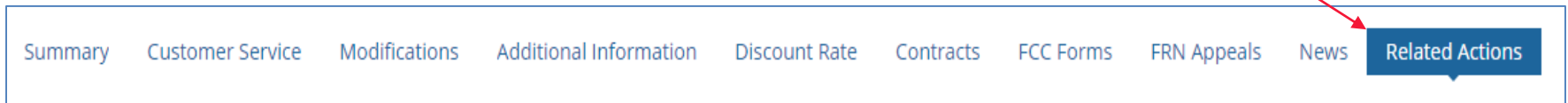
- FY 2017 Form 472 (BEAR) deadlines are:
  - October 28, 2018 for recurring services
  - January 28, 2019 for non-recurring services (such as equipment)
- Applicants that cannot meet this deadline may request a single, 120-day extension of that deadline, but the request **MUST** be submitted by the original BEAR deadline
  - However, I strongly encourage you to submit all BEARs by their original deadline because the risk that you'll forget to do it later is too high
- Beginning October 1, 2018, entities must file all IDER requests in their EPC portals
  - If you previously requested/received an extension, you do not have to resubmit it using the new tool

# Finding the New IDER Tool

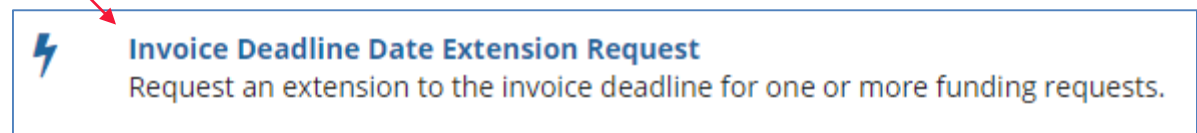
1) From your EPC Landing Page, click on your School or Library's Name under the USAC Logo



2) Select Related Actions from the top toolbar



3) Scroll to the bottom of the list, and select Invoice Deadline Extension Request
